Presentations of present hunting methods from six different areas, with focus on lesser-described hunting methods and methods where harpoon and killing weapon are not a combined weapon (e.g., hand harpoon hunts, rifle hunts for small cetaceans, minke whales, and seals), and for which there is less knowledge and data on the outcome (welfare and losses).

- Do existing domestic and international hunting laws and regulations adequately support welfare, or do they need to be adapted?
- What are the most required improvements in terms of welfare outcomes? How can we achieve the desired welfare outcomes, considering the diverse circumstances of different countries and regions?
- How to best prioritise the efforts (which criteria to use: cost (effort and financial)
 versus the overall 'qualitative' gain in terms of improvement of welfare outcomes,
 level of losses (struck & loss), level of animals' awareness, etc.)
- Can we identify common fields of welfare-related research that would lead to cooperative projects and collective expertise building?
- o How to continue addressing hunters' safety in future discussions

- Summary of priorities for improving welfare outcomes (e.g., criteria, hunts...)

- Which steps should be taken to progress towards improving welfare outcomes in marine mammal hunts (e.g., which themes should be covered by future Expert Groups/Workshops, common research projects, ensuring hunters' participation, etc.)
